CONDITIONS OF BITCH

Minimum 2 years of age. Good health/condition.

1. No disqualifying faults as noted in the Breed Standard.
2. Stable temperament in keeping with the Breed Standard.
3. AKC CHAMPION or Major Pointed.
4. Has not been exposed to another Stud Dog during current heat cycle.

5. Must have CERF test done within a 12 month period.
6. Must have proof of BAER normal test.
7. Must have negative Brucellosis and have been wormed within 30 days of breeding.

STUD OWNER AGREES TO:

1. Provide bitch owner with a complete 4 generation pedigree of the Stud Dog.
2. Take normal adequate care of bitch while in our charge.
3. Have the Stud dog in good physical condition and current brucellosis test.
4. Sign litter registration promptly and return to bitch owner when litter is whelped.
5. Provide the bitch owner with a written receipt for the stud service and a record of the breeding dates.

GUARANTEE

1. Owner of sire guarantees a litter of 2 live puppies at birth.
2. One replacement breeding to the same bitch at next heat cycle or 12 months if less than 2 live pups.

OTHER EXPENSES

1. Bitch owner is responsible for all fees associated with this breeding.
2. Veterinary expenses will be paid to the Vet directly by Bitch owner. This includes but is not limited to, Ovulation testing if needed on the Bitch, collection and shipping fees.
3. Boarding charges of \$_____ per day after 7 days.
4. Airport Transfer charges will be \$_____ each way
5. Stud Dog owner will not be required to sign AKC litter registration papers for said litter until all expenses/Stud fees are paid in full and all conditions of this agreement have been fulfilled.
6. Stud fee in part or whole will not be refunded for any reason.

ARTIFICIAL INSEMINATION

1. Using Fresh Extended Semen: The AKC certification form, "Application for using Frozen Semen", must be filled in and signed by the Bitch owner.
2. The Bitch owner will reimburse the Stud owner for veterinarian charges for the collection of the semen, the shipping container, and all other packaging and handling fees incurred in the shipping of the specimen.
3. Using Frozen Semen: The Bitch owner will reimburse the Stud owner for shipping container charges, and all other packaging and handling fees incurred in the shipping of specimen charge by the storage facility.

TERMS

1. The Bitch owner hereby releases from responsibility Cobblestone Parson Russell Terriers, or Michael and Michele Asher or its officer from any and all liabilities

and/or damages to said Bitch while she is in their care of Cobblestone Parson Russell Terriers for breeding.

2. Any Legal action filed by either party in an effort to enforce this contract will be filed in Oakland County, Michigan.

It is agreed between the Stud owner and the Bitch owner that the puppies from this breeding will be sold exclusively by the owner of the bitch, and be sale of the puppies will not be made to any owner, employee, agent, or individual connected with a pet shop, specialty shop, or wholesaler of dogs
